1. Data provided via **contact form**: name, company name, email address
2. **Technical data**: IP address, browser type, pages visited, visit duration (Google Analytics)
3. **Email data**: email addresses via Resender service

## Data Recipients

We share data only with processors under Data Processing Agreements:

- **Google Analytics** (USA servers, EU SCCs applied)
- **Resender** (email service provider)

No data sales or sharing with other third parties.

## Data Retention Period

- Contact form data: 3 years (Polish limitation period for claims)
- Analytics data: 14 months maximum
- Email data: until consent withdrawal or purpose completion

Data is securely deleted after retention periods.

## Your Rights

You have the right to:

- Access your personal data
- Rectify inaccurate data
- Erase your data ("right to be forgotten")
- Restrict processing
- Data portability
- Object to processing
- Withdraw consent (does not affect prior processing)
